1. Introduction

We continuously evaluate environmental and climate-related risks and opportunities¹, focusing our efforts on what is most significant.

We set measurable and time-bound goals and communicate our results transparently.

5. Own operations

We aim to minimize our negative environmental and climate impact by:

- collaborating with our customers and other stakeholders,
- considering environmental and climate risks and opportunities throughout the value chain in investments, procurement, and projects,
- systematically working to reduce the need for energy and using renewable energy where possible,
- working to reduce our negative environmental and climate impact from business travel,
- preventing the generation of waste. Where possible, there should be opportunities for reuse and recycling,
- increasing awareness among our employees about our environmental and climate impact through information and training,
- ensuring that routines are available and communicated to ensure compliance with applicable environmental laws.

6. Our products and services

We aim to minimize our negative environmental and climate impact by:

- making conscious choices regarding raw materials, production, and freight transport,
- working to reduce the environmental and climate footprint associated with the use of our products and services,
- promoting reuse, recycling, and efficient waste management of our products,
- setting requirements for and monitoring our suppliers,
- providing clear information to our customers to assist them in making more sustainable choices.
